Admission Procedure for International students

In the light of transforming affiliated to autonomous KEC decided to follow the below admission procedure for acquiring international students.

SUPERNUMERARY QUOTA FOR FOREIGN NATIONALS (FN), OVERSEAS CITIZEN OF INDIA (OCI), PERSONS OF INDIAN ORIGIN (PIO) & CHILDREN OF INDIAN WORKERS IN GULF COUNTRIES (CIWGC)

For the purpose of admitting students from foreign nationals, overseas citizens of India, persons of Indian origin (FN/OCI/PIOs), and children of Indian workers in the Gulf countries, a supernumerary 15% increase over the "Approved Intake" per course is permitted in all AICTE-approved institutions and university departments that offer technical courses. Of these 15% of seats, a third (1/3) will be set aside for the Children of Indian Workers in the Gulf Countries(CIWGC).

Out of the quota of 1/3 seats allotted for children of Indian workers in the Gulf countries, any vacant seats in a particular course will be reverted to the 2/3 seats designated for OCI/PIO/foreign nationals, and vice versa.

Furthermore, following the last phase of admission by the relevant State Government, any open seat in the "Approved Intake" may be filled by Foreign Nationals, Overseas Citizens of India, Persons of Indian Origin (FN/OCI/PIOs), or Children of Indian Workers in the Gulf Countries (CIWGC), provided that the AICTE approves the aforementioned quota and that the necessary infrastructure is completed in accordance with the Approval Process Handbook. (AICTE Approval Process Handbook 2020-21)

PROCEDURE TO BE FOLLOWED FOR FN/OCI/PIO

The filled-in applications along with following supporting documents should be sent only through courier with the following enclosures:

- 1. Original Demand draft for the Application Fee of 25 USD
- 2. Four passport size photos with names written at the back.
- 3. Copies of statement of marks of Class 10, Class 11, and Class 12 (A-level). If results are awaited, marks available currently.
- 4. Equivalence Certificate from Association of Indian Universities.
- 5. Copy of Transfer Certificate from the last institution attended
- 6. Copy of Passport
- 7. Copy of Visa (if available)

PROCEDURE TO BE FOLLOWED FOR CHILDREN OF INDIAN WORKERS IN GULF COUNTRIES (CIWGC)

Documents to be submitted by Children of Indian Workers in Gulf Countries:

- All the relevant academic documents.
- Father's or Mother's Visa copy in English. (Translated to English and uploaded)
- No Visiting Visa holder nor one who holds a Visa with 'Housewife' status can sponsor a student.
- Father's OR Mother's Certificate of employment on company letterhead, which is valid & attested by the Indian Embassy or Ministry abroad, or Sworn affidavit on employment, endorsed by the Indian Embassy. Upload copy (Original should be submitted in office) Any attempt to mislead by

furnishing false information or fictitious document regarding employment, relationship with candidate etc will be liable for civil or criminal action as warranted by the appropriate law and the applicant and the parent or guardian will be squarely held responsible for such acts or attempts and the institutions will not bear any responsibility in this regard.
